- I voluntarily seek child care provided by Mini Scientist Group child care LLC and acknowledge that I am increasing my risk to exposure to the Coronavirus/COVID-19.

- **I attest that:**

- * My child is not experiencing any symptoms of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.

- *My child has not traveled internationally within the last 14 days.

- * If my child has/will travel to a highly impacted area within the United States of America in the last 14 days that they will notify the Director of travel.

- * I do not believe that my child has been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.

- * My child/children have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non contagious by state or local public health authorities.

- * That me and my family are following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

I hereby release and agree to hold Mini Scientist Group child care LLC harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of the child care, or that may otherwise arise in any way in connection with any services received from Mini Scientist Group child care LLC. I understand that this release discharges Mini Scientist Group child care LLC from any liability or claim that I, my heirs, or any personal representatives may have against the child care with respect to any injury, illness, medical treatment, or property damage that may arise from, or in connection to, any services received from Mini Scientist Group LLC. This liability waiver and release extends to the child care together with all owners, partners, and employees.
